Small minarets made of wood and metal are built here, but we have to know the size and design you wish before we start construction. After you have paid for the minaret, we begin construction immediately."

After giving the clerk the specifications for the minaret he wanted, the muhtar asked, "When could such a minaret be available?"

The clerk answered, "It will be built today and set afloat on a large log raft down the Çoruh River. It will reach such and such a village by six or seven o'clock tomorrow morning.
